“As a parent of a 42-year-old daughter challenged with intellectual disabilities, I used to lie awake at night worrying about who is going to look after Jennifer when my husband and I die. Parents often worry about unknowns such as where their adult child with life-long disabilities will live; who will advocate for their child; and what kind of vocational, recreation, residential and support services will their child need and receive. Parents will gain great peace of mind if they take the time to plan for their child’s future while they still have the health, time and energy to do so,” said Theresa Varnet.



Theresa Varnet has been an advocate for persons with disabilities for over 40 years. In addition to being a certified

teacher, licensed social worker and graduate of the DePaul University College of Law, she is the parent of an adult daughter with a disability.

The Arc of hosted a seminar titled “Life Long Planning for Your Relative with Special Needs” presented by Theresa M. Varnet M.S.W., J.D. and Rich Harwood CLU, CAP, Special Needs Planner on January 10 at the Venus de Milo in Swansea, MA. Over 70 people attended the informative seminar covering the topics: Negotiating the Social Security Maze; Preserving Eligibility for Government benefits through Proper Estate Planning; Special Needs Trusts; Guardianship and Less Restrictive Alternatives-The Implications for Consent; Health Care Proxies (Advance Directives); and Selecting a Knowledgeable Attorney.

As 2014 came to end, we have had significant activities in both the state and federal governments. At the state level, we learned of the key leadership changes in both Massachusetts and Rhode Island and celebrated the passage of key laws providing expanded eligibility, improved safeguards, and Autism services. As the new state budgets take shape, we will need to closely monitor and advocate that services are adequately funded with no reductions.




At the federal level, we celebrated the passage of the ABLÉ Act- a futures planning tax tool that will enable individuals to build supplemental needs accounts for the years to come. The Centers for Medicaid and Medicare Services released reports concerning compliance with the Community Rule and the Department of Labor enacted the Domestic Service Final Rule to the Fair Labor Standards Act. In addition, we are closely monitoring legislation that would negatively impact those receiving Social Security Disability Insurance (SSDI) benefits. All of these initiatives will have a long standing impact on future services and we are thankful for the public policy efforts of The Arc of Massachusetts and The Arc of the United States.

Once again, we have been fortunate to provide and participate in many holiday activities for the individuals we support. I cannot express

enough thanks to the Holiday Planning Committee members, volunteers and the community organizations that supported our endeavors. We sincerely appreciate the joy that it has brought to so many individuals and families.

As we embark on a new year, I would like to extend my greatest thanks to all of you for your continued support. Thanks to the commitment and support of staff, volunteers, and the community, The Arc had many outstanding accomplishments in 2014. The Arc Marks Passage of ABLÉ Act

Washington, DC – Today, as the U.S. Senate passed the Achieving a Better Life Act (ABLE Act), The Arc, the nation's largest organization for people with intellectual and developmental disabilities (I/DD), released the following statement:

"We are pleased that the Achieving a Better Life Experience Act has been approved by both the U.S. House of Representatives and now the U.S. Senate. With the clock winding down on this session of Congress, now this important legislation can move to President Obama's desk. We appreciate the untiring work of the chief sponsors of the bill and the support of a large and broad representation in both chambers of Congress.

"While the legislation was narrowed due to the constraints from the

cost analysis, the approved bill will provide a vehicle for some families and people with intellectual and developmental disabilities to save for the future, depending on their own circumstances. Our efforts will not be finished if President Obama signs this bill – The Arc will continue to work with the leadership and chief sponsors in Congress to expand this program in the future to ensure that everyone in need can get the maximum benefit from this legislation. We remain disappointed that certain pay-fors remain in the bill," said Peter V. Berns, CEO of The Arc.

The ABLÉ Act aims to change the tax code to allow for tax advantaged savings accounts for individuals with disabilities for certain expenses, like education, housing, and transportation.

Similar to existing "Section 529" education savings accounts, ABLÉ accounts would let families save for disability-related expenses on behalf of qualified beneficiaries with disabilities that will supplement, but not replace, benefits provided through the Medicaid program, the Supplemental Security Income program, the beneficiary's employment, and other sources. If properly managed, funds in the ABLÉ accounts would not jeopardize eligibility for critical federal benefits. With full understanding of its features, individuals and families could use the ABLÉ accounts as another tool in planning for the lifetime needs of an individual with long term disabilities.

Note: On Friday, December 19, 2014, President Obama signed the ABLÉ Act into law.
